There were about 15 court decisions on illegal shipment of waste, but details not available of all of them. There was no extraordinary serious case. For available details about court decisions and administrative sanctions see below. There were also 100 take-backs with a total amount of about 3100 metric tons, about 80 cases of environmentally sound waste treatment in local facilities near the inspection place with about 500 tons of waste treated. These incidents are considered as minor cases as long as there is no significant penalty. As it is a huge amount of data, providing details is regarded as disproportionate. Some of them may appear later with details, when there is a court decision or an administrative fine. There were also about 40 cases of punishment for minor violations with fines not exceeding 200  $\in$ .
